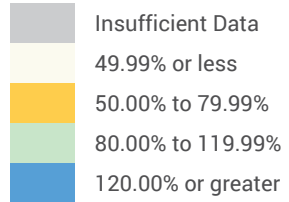
19300 - Daphne-Fairhope-Foley Assessment Area

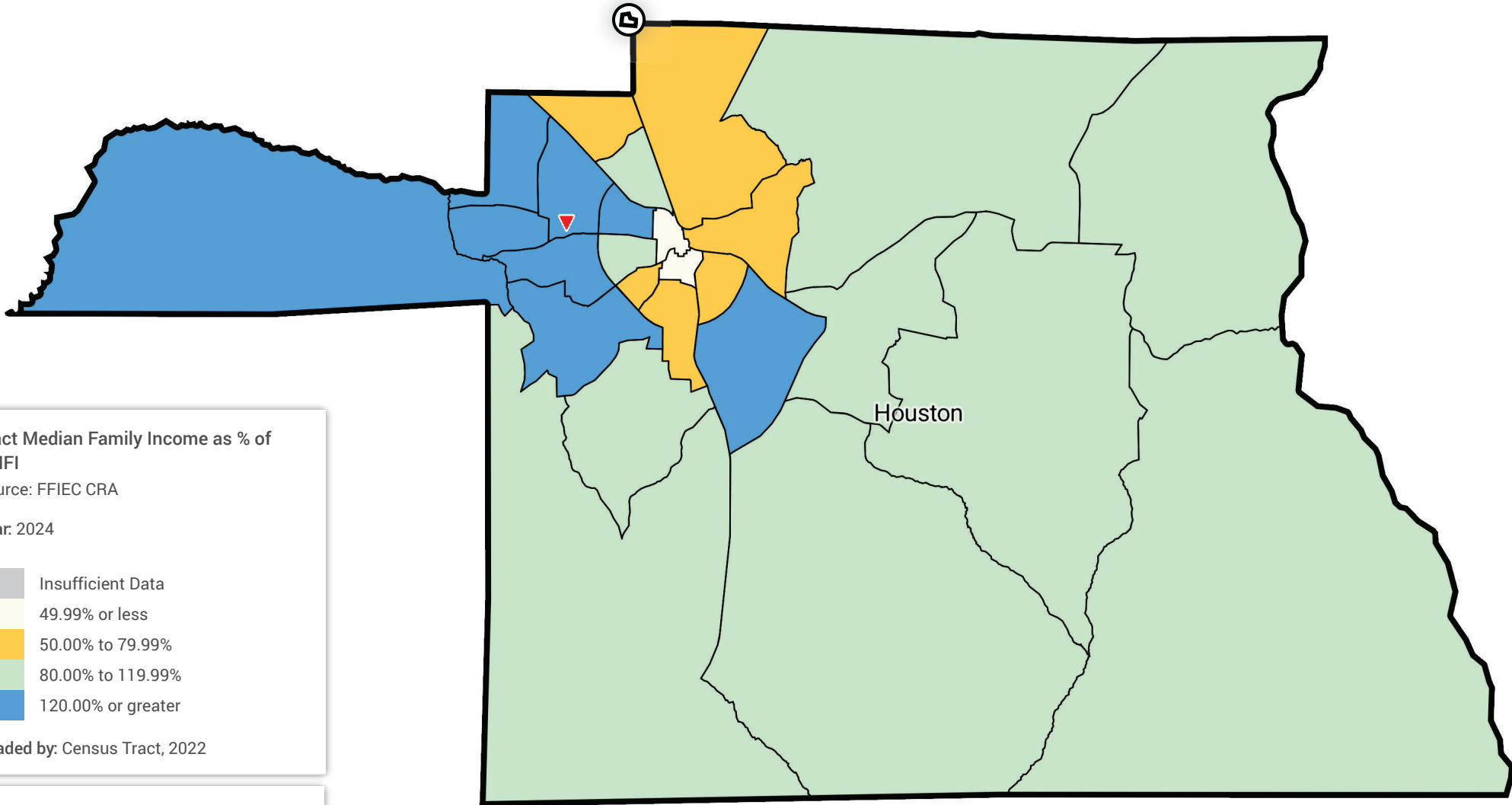

2020 - Dothan AL Assessment Area



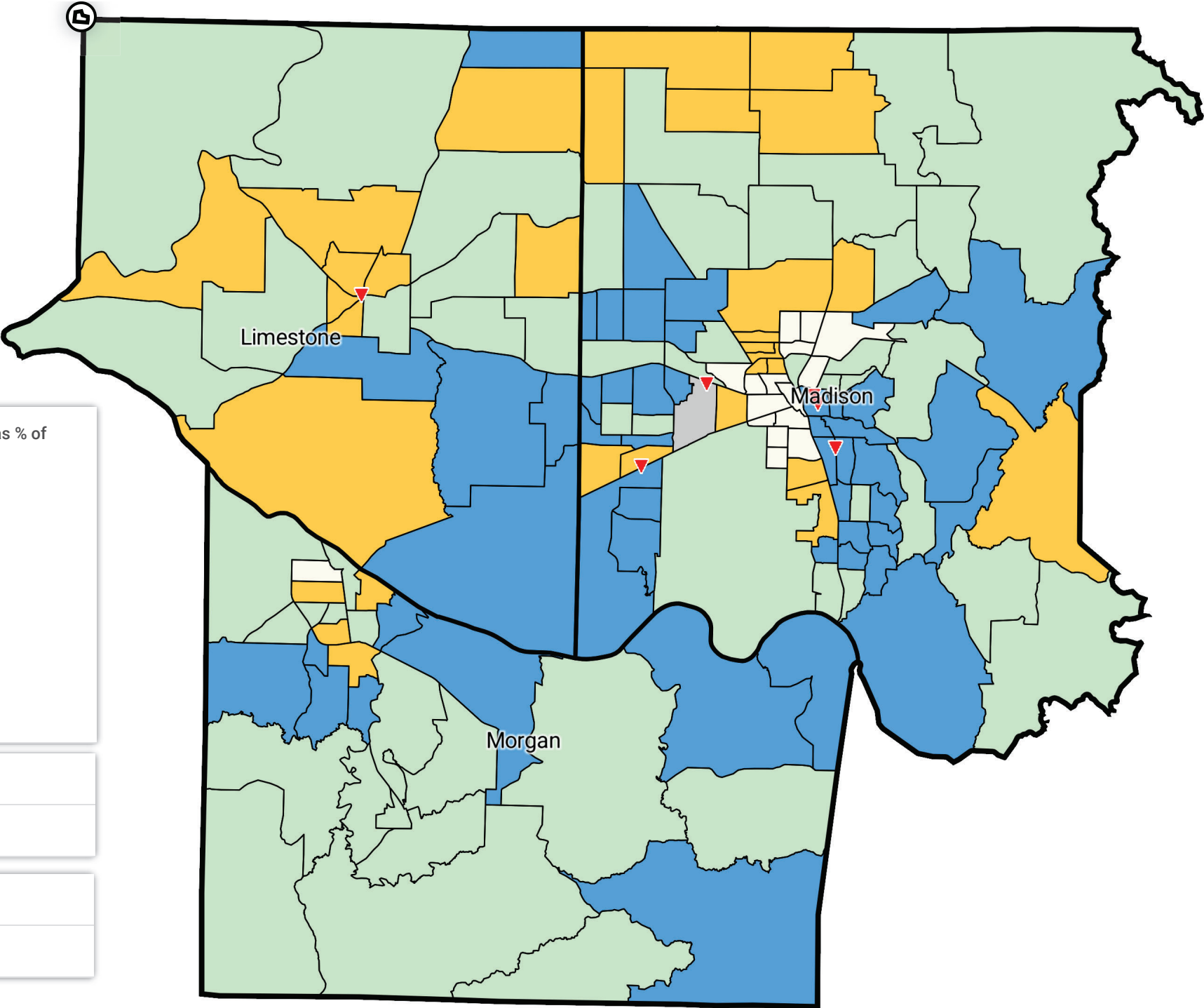

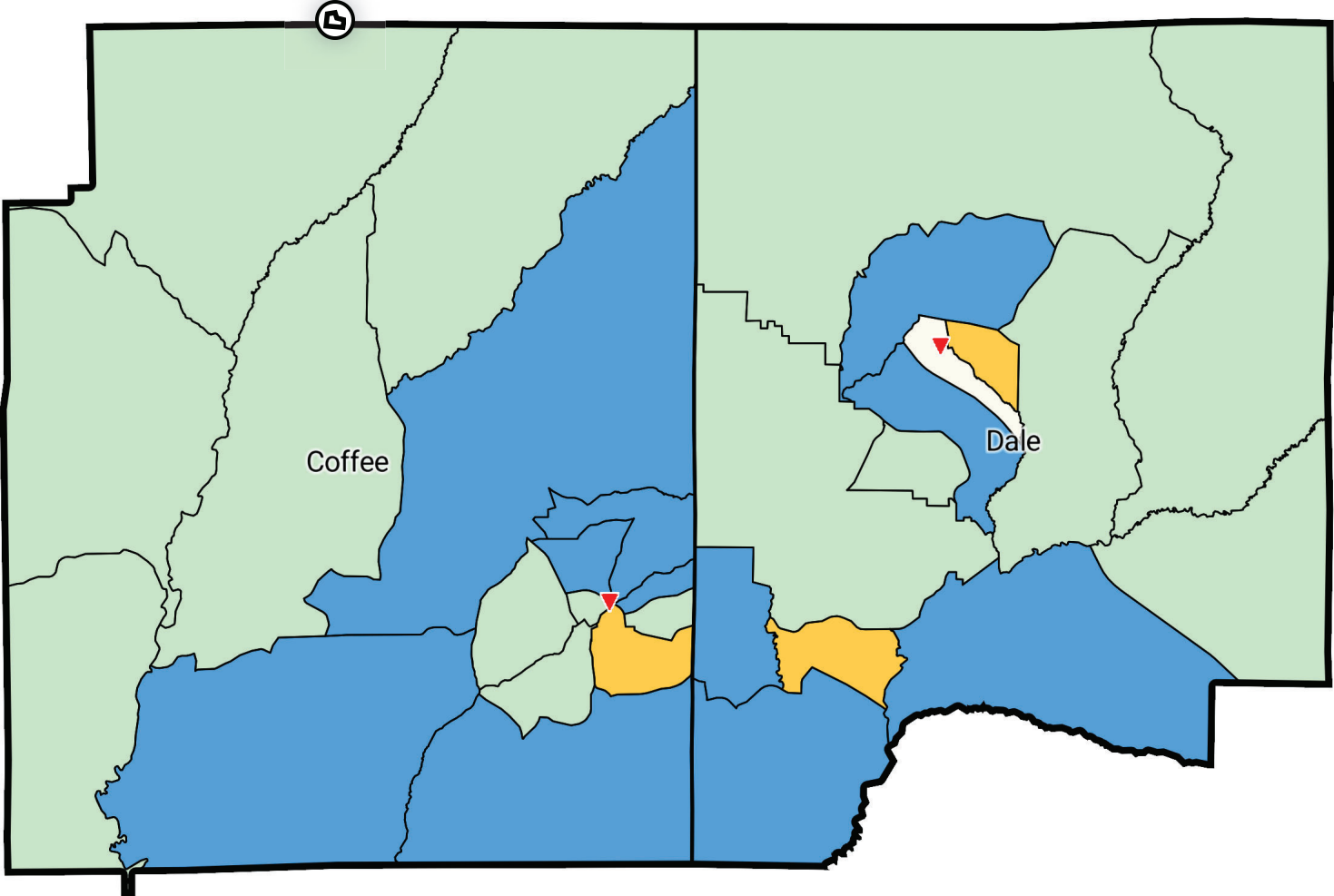

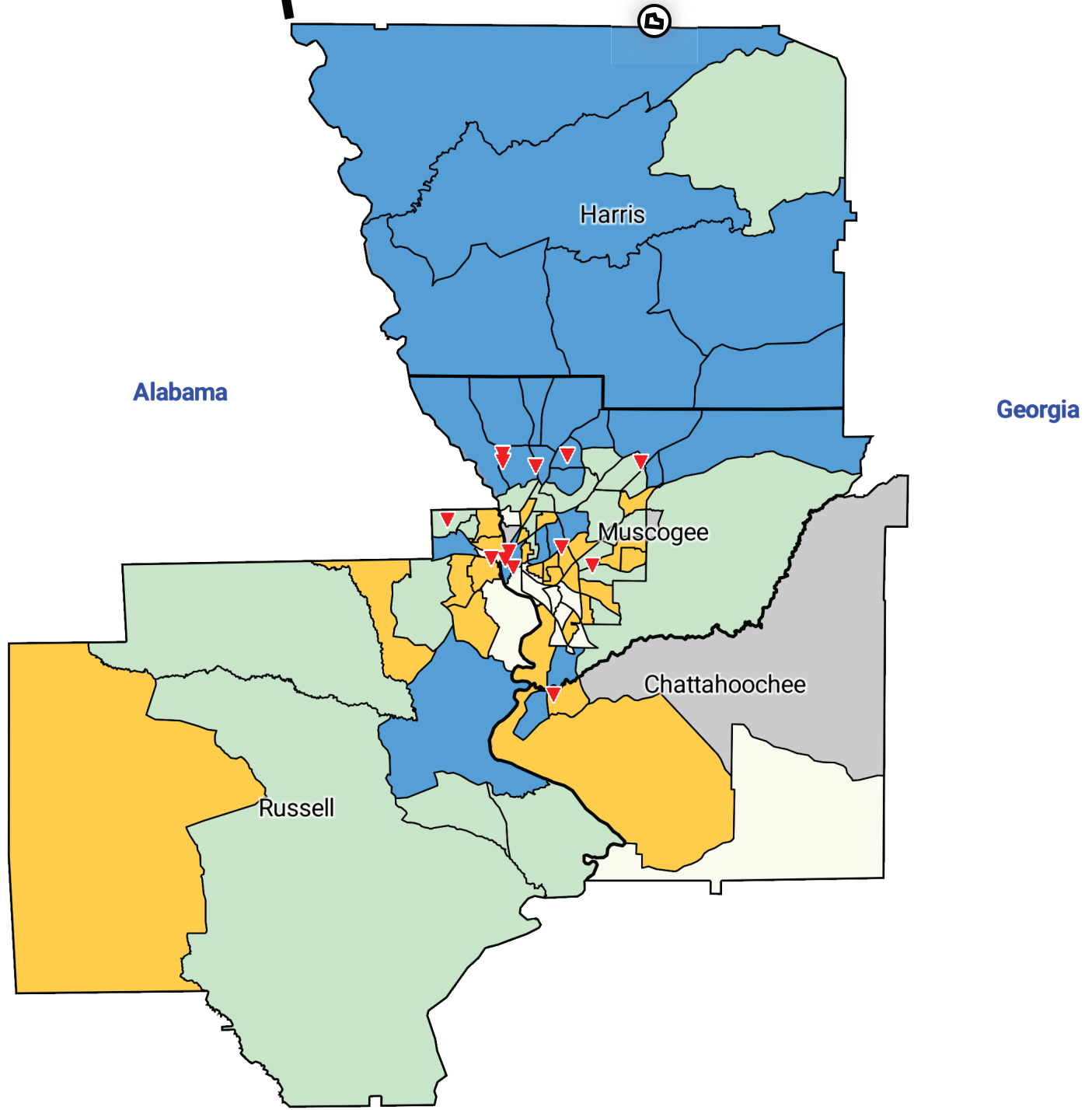

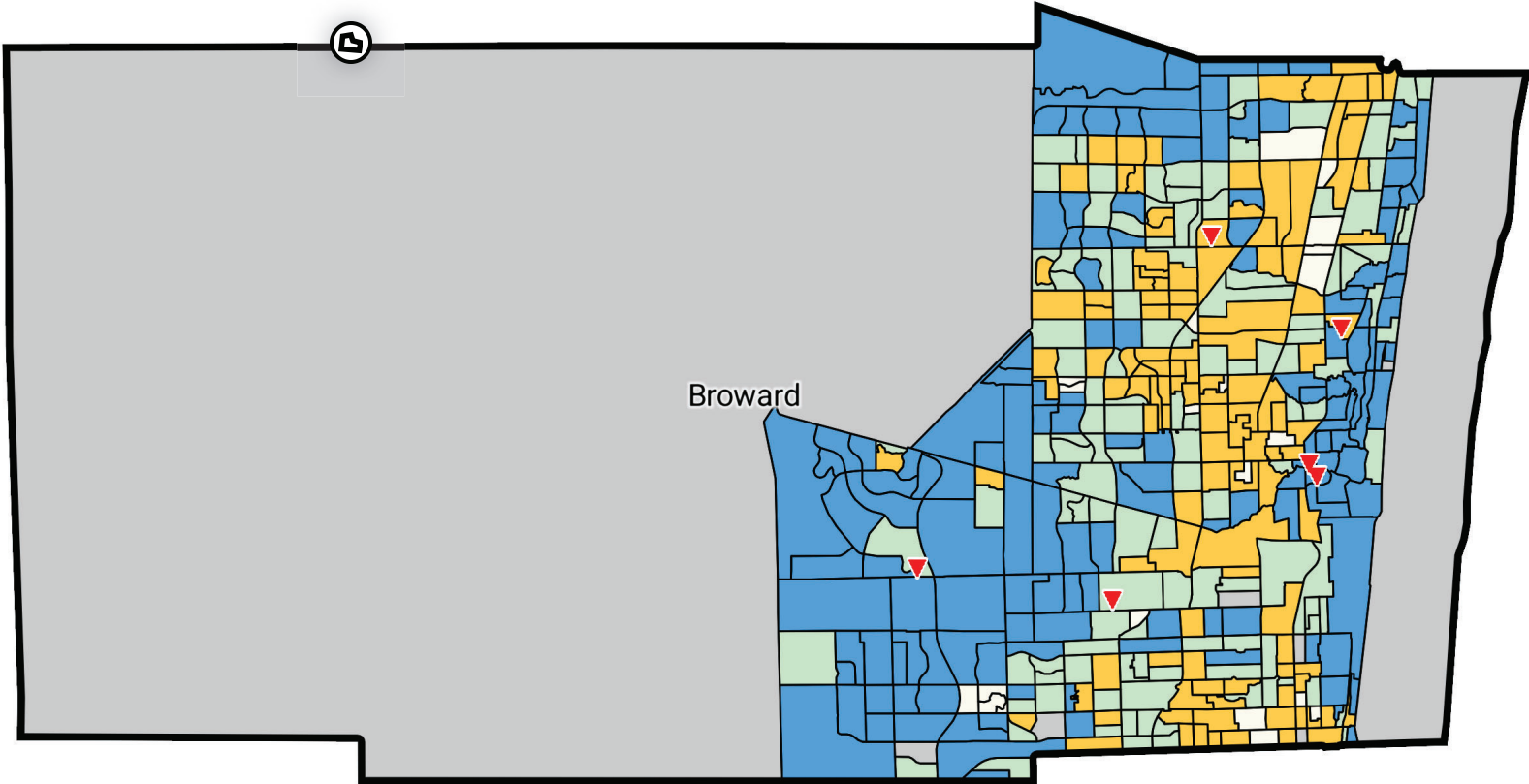

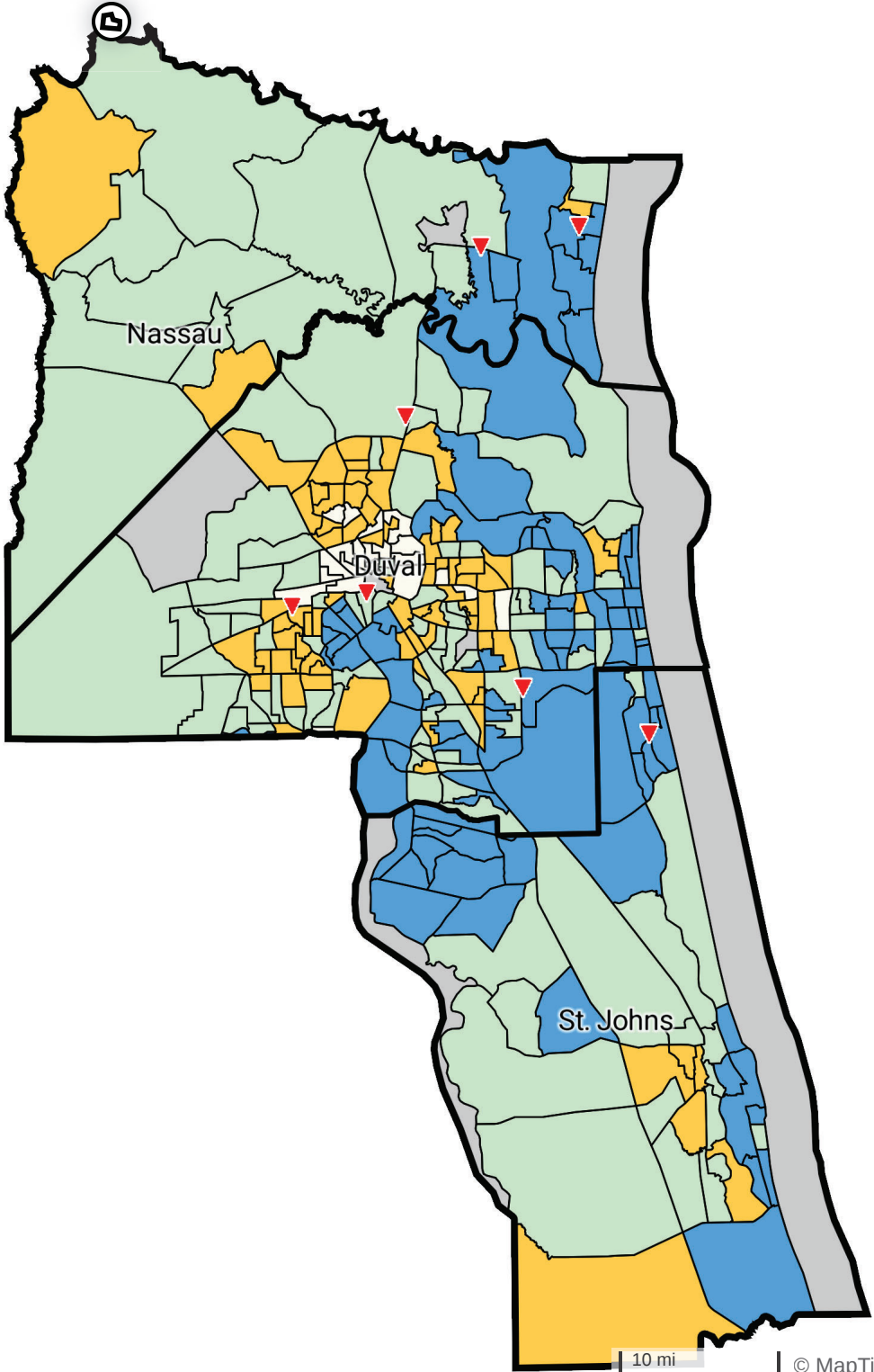

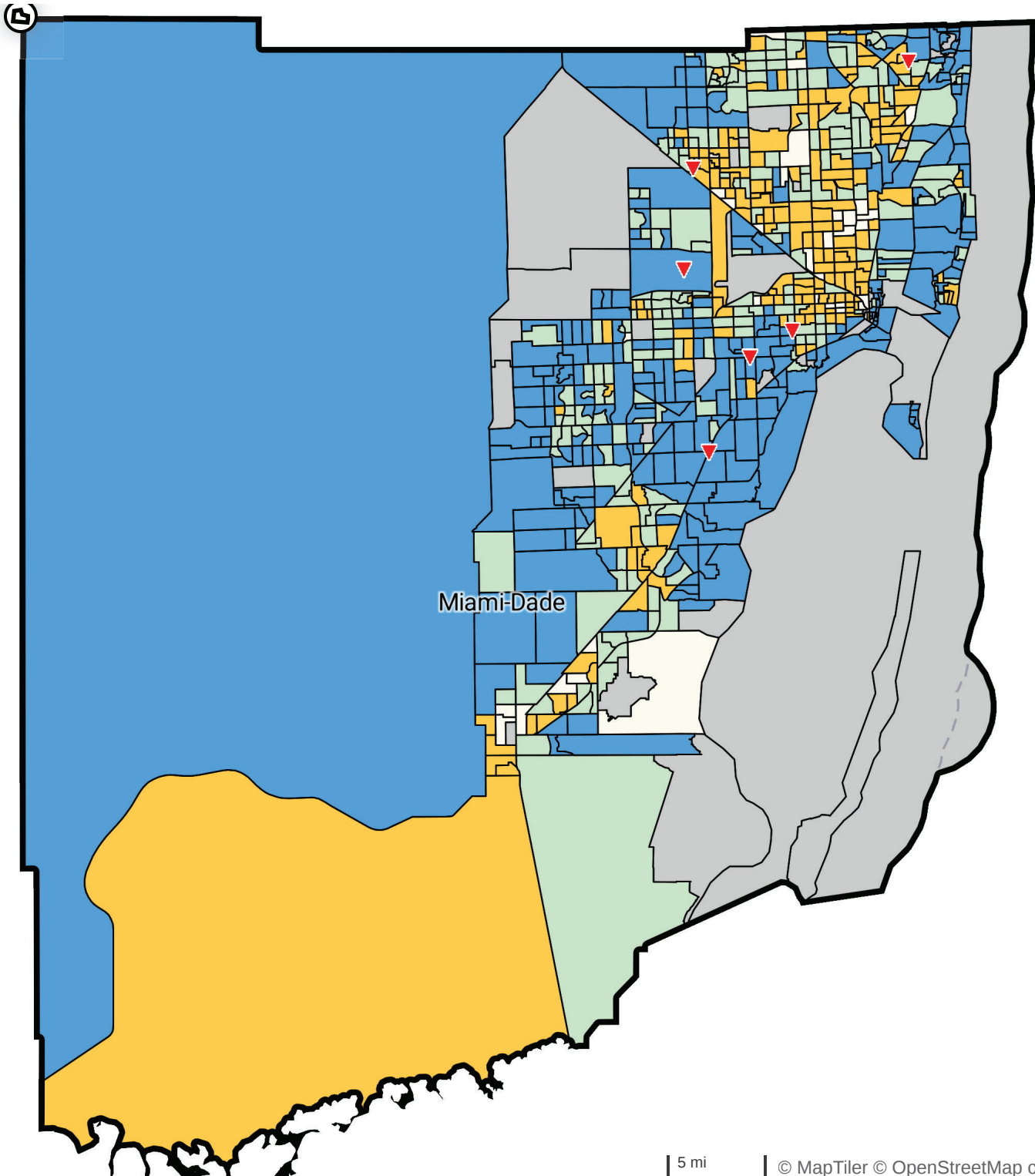

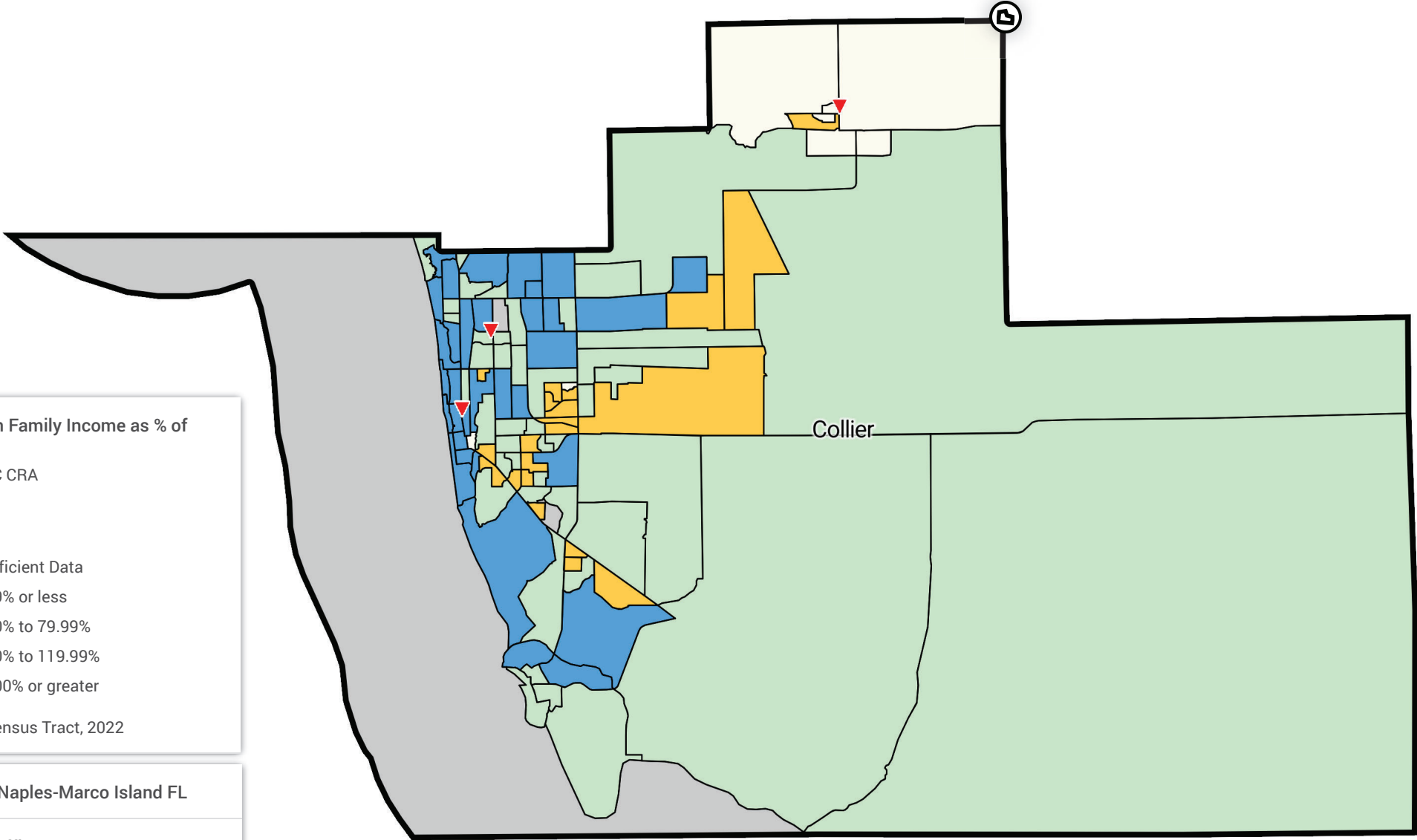

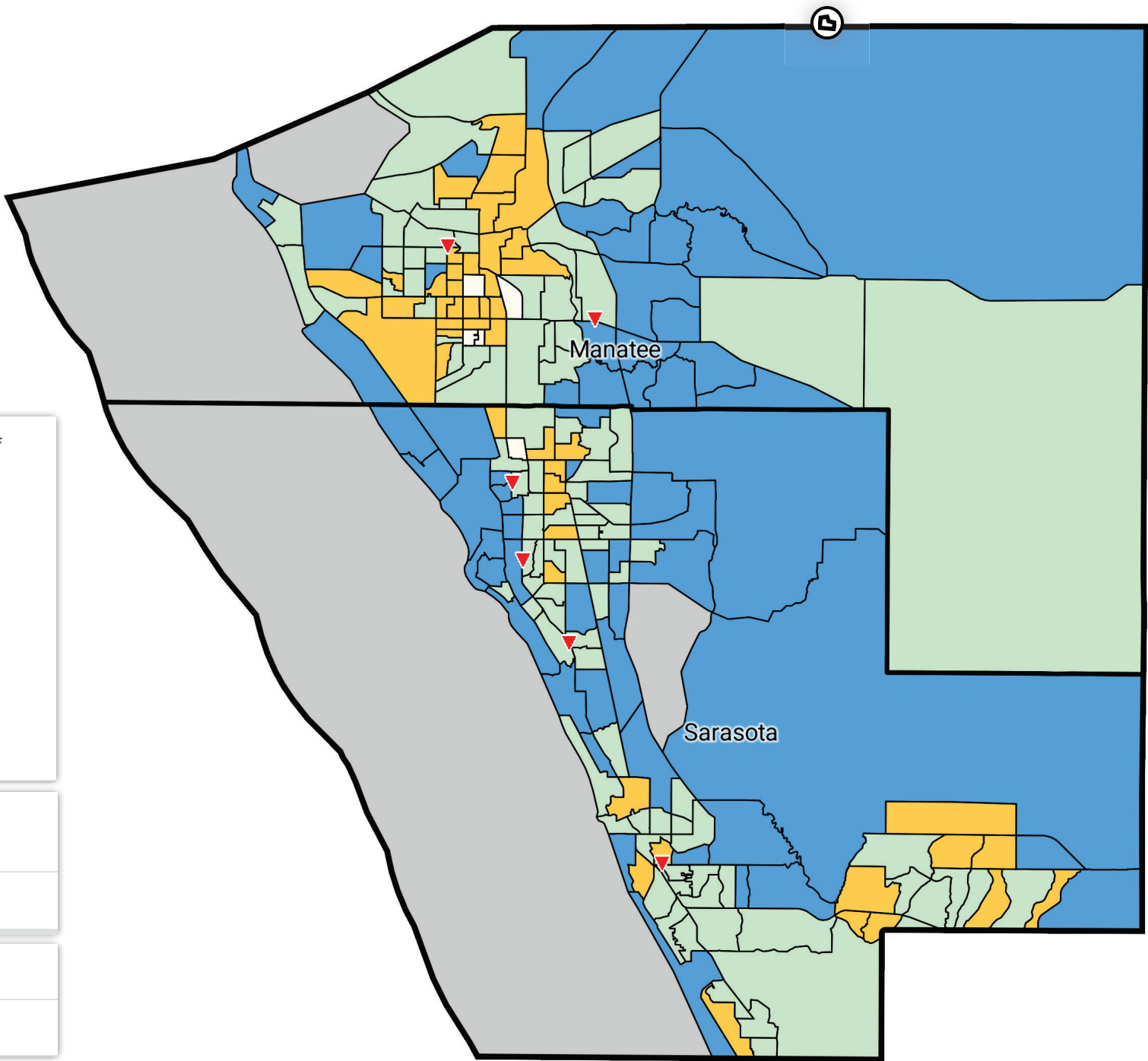

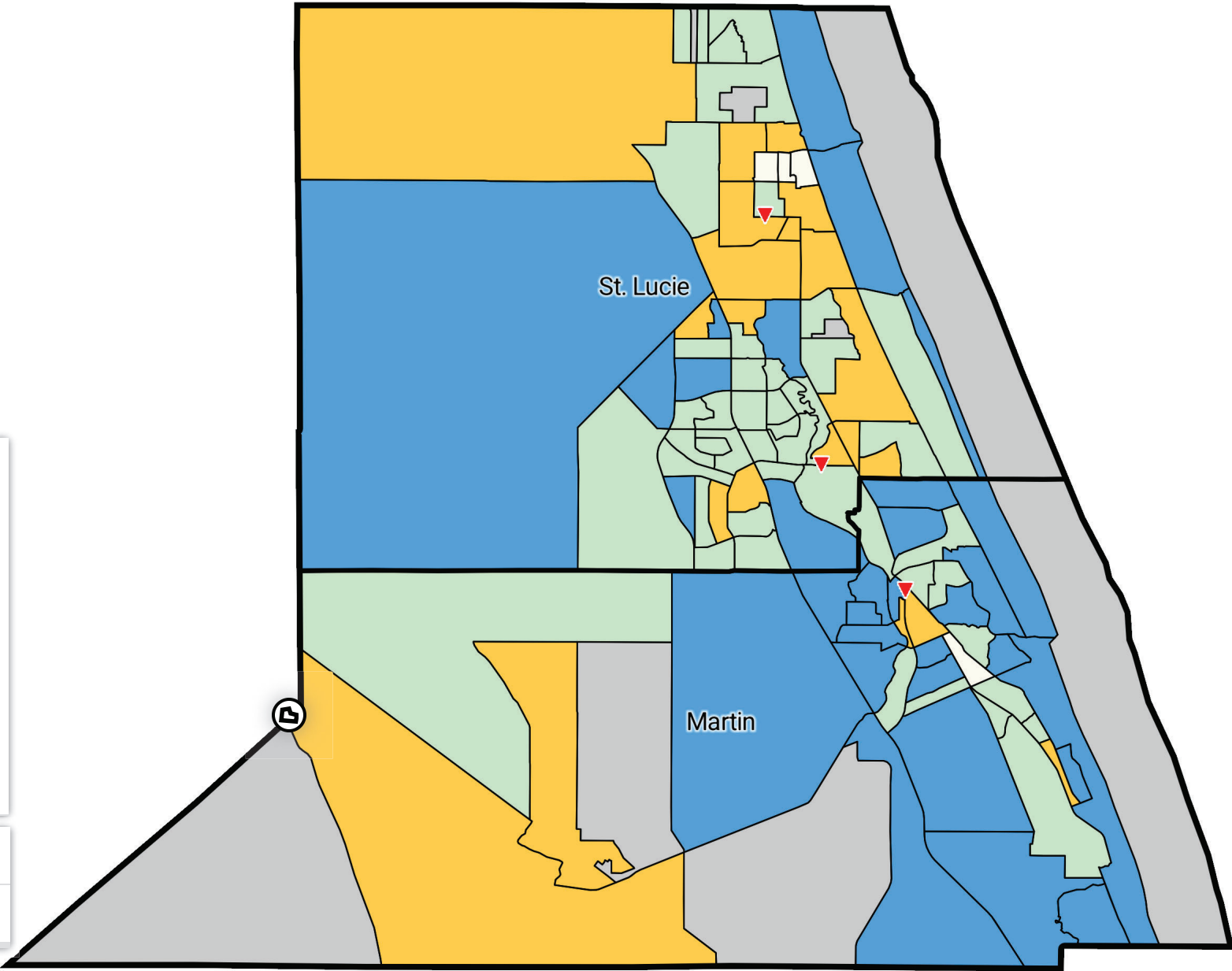

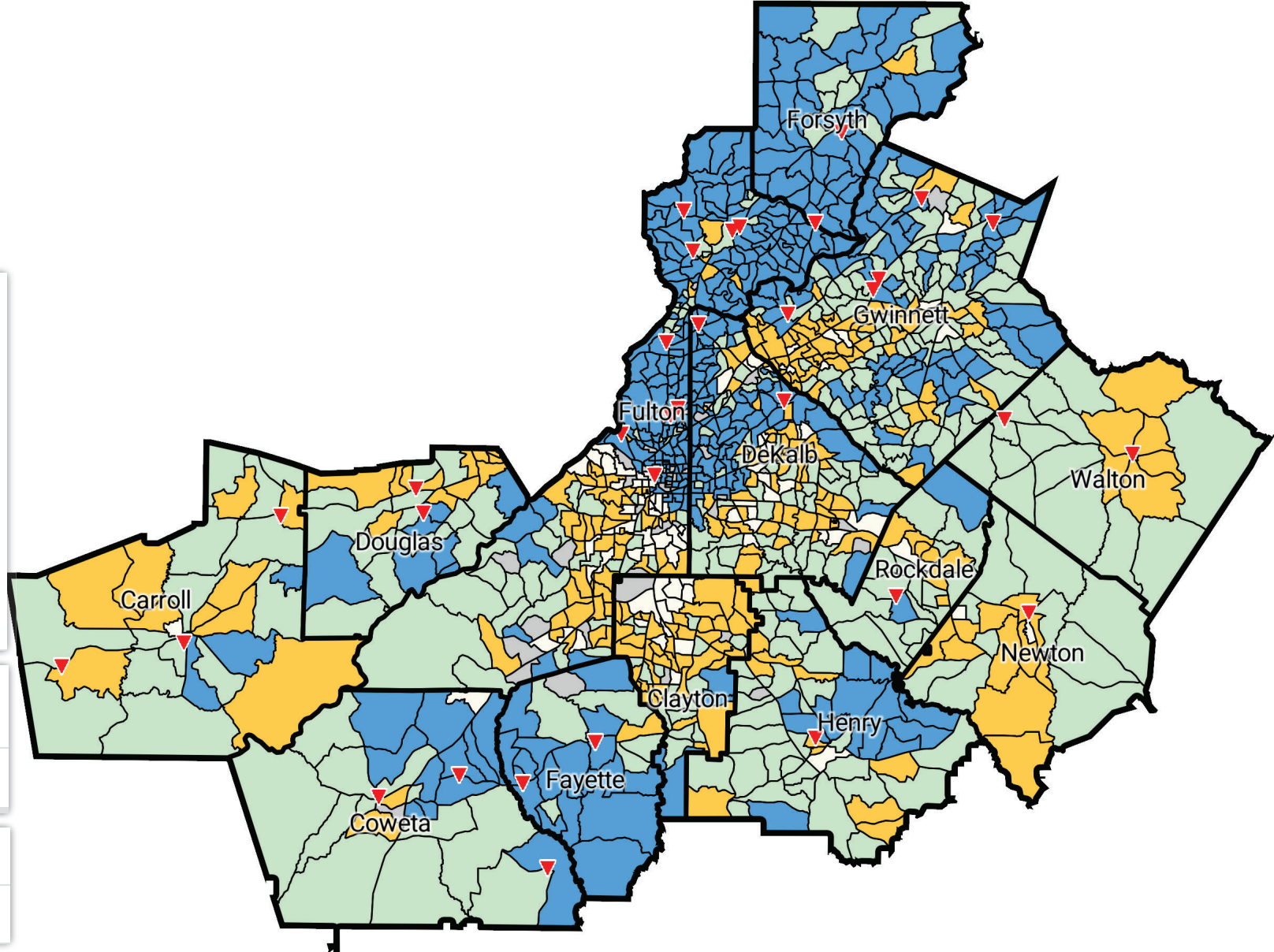
12054 - Atlanta-Sandy Springs-Roswell GA Assessment Area

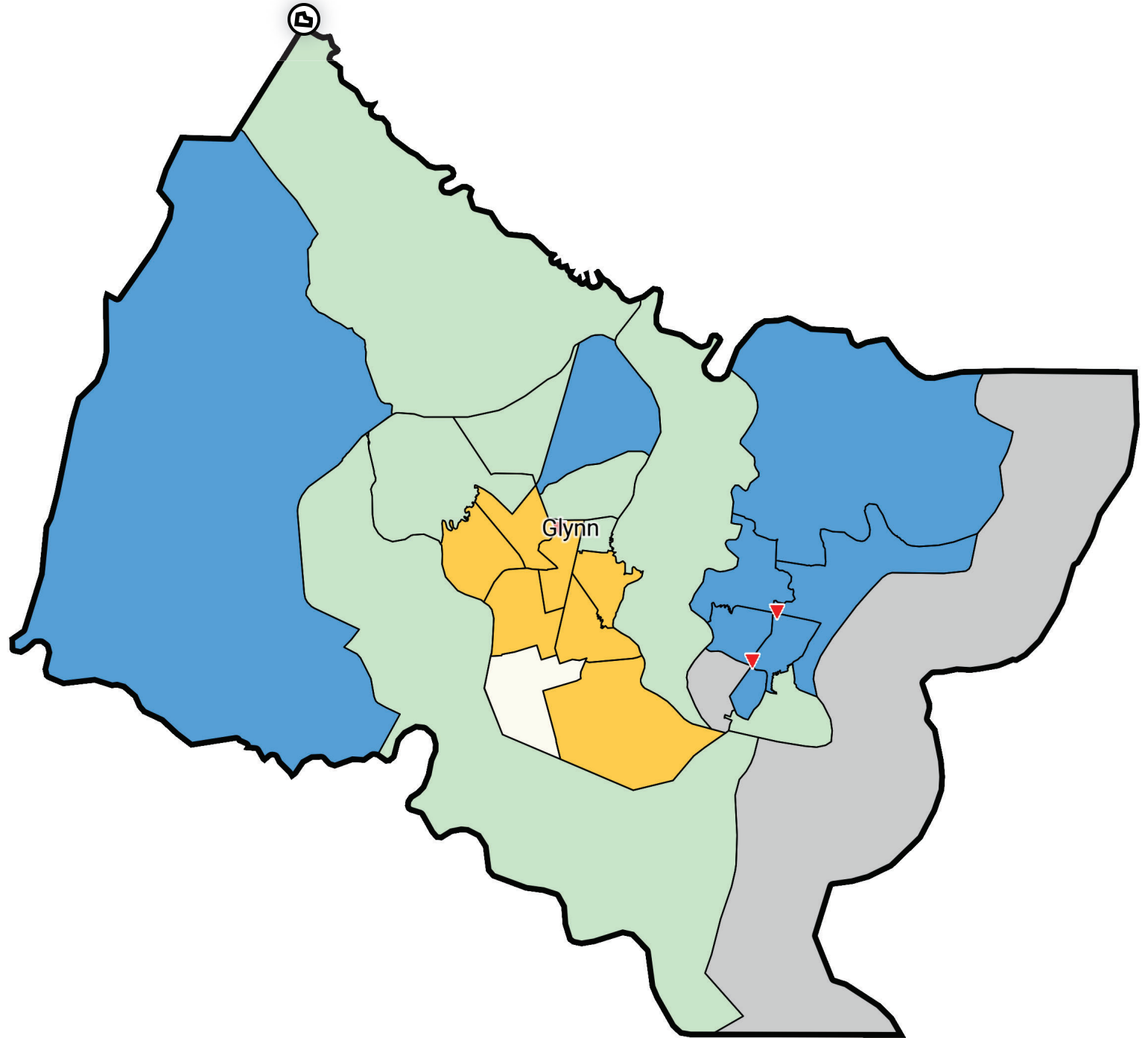

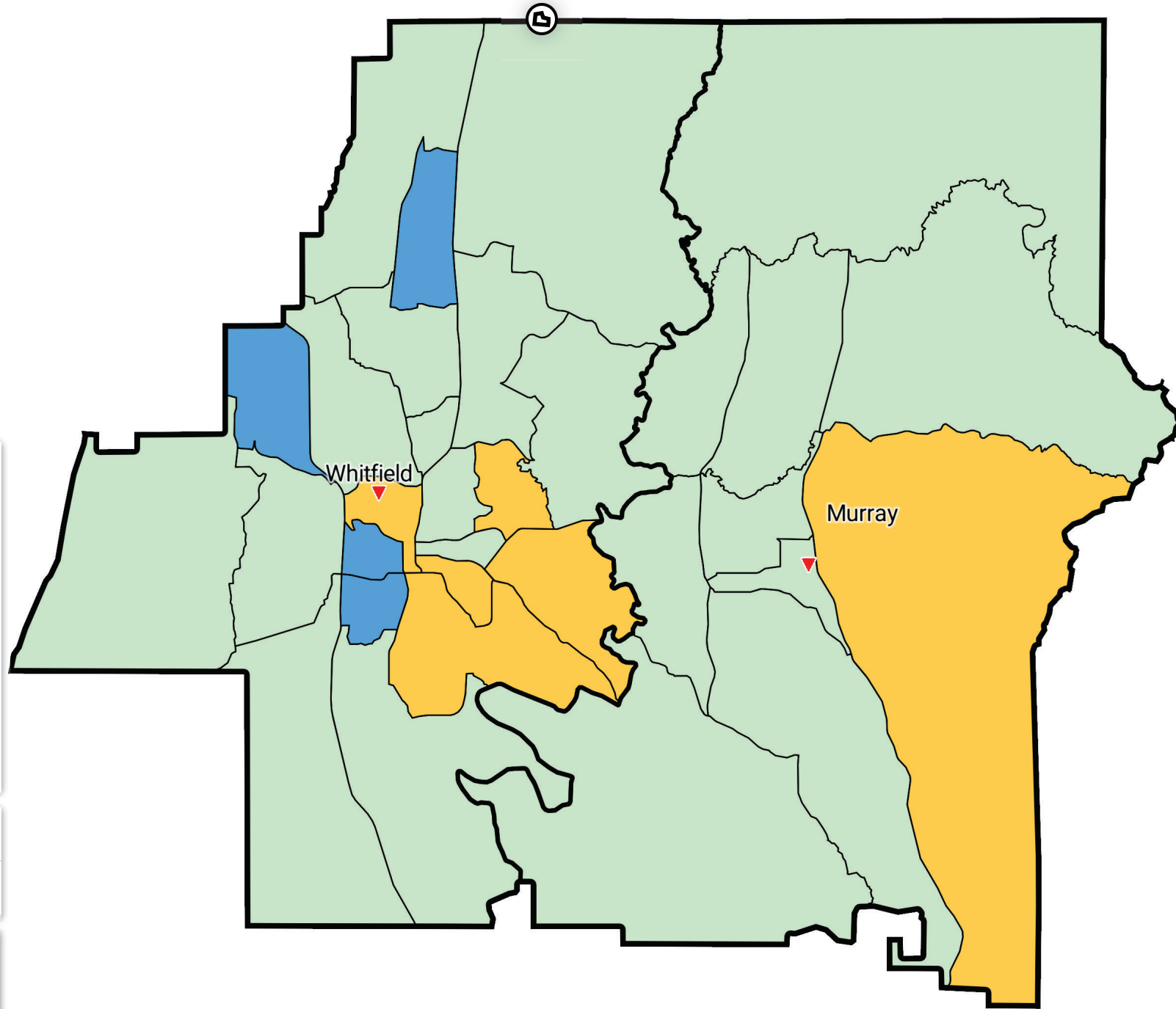

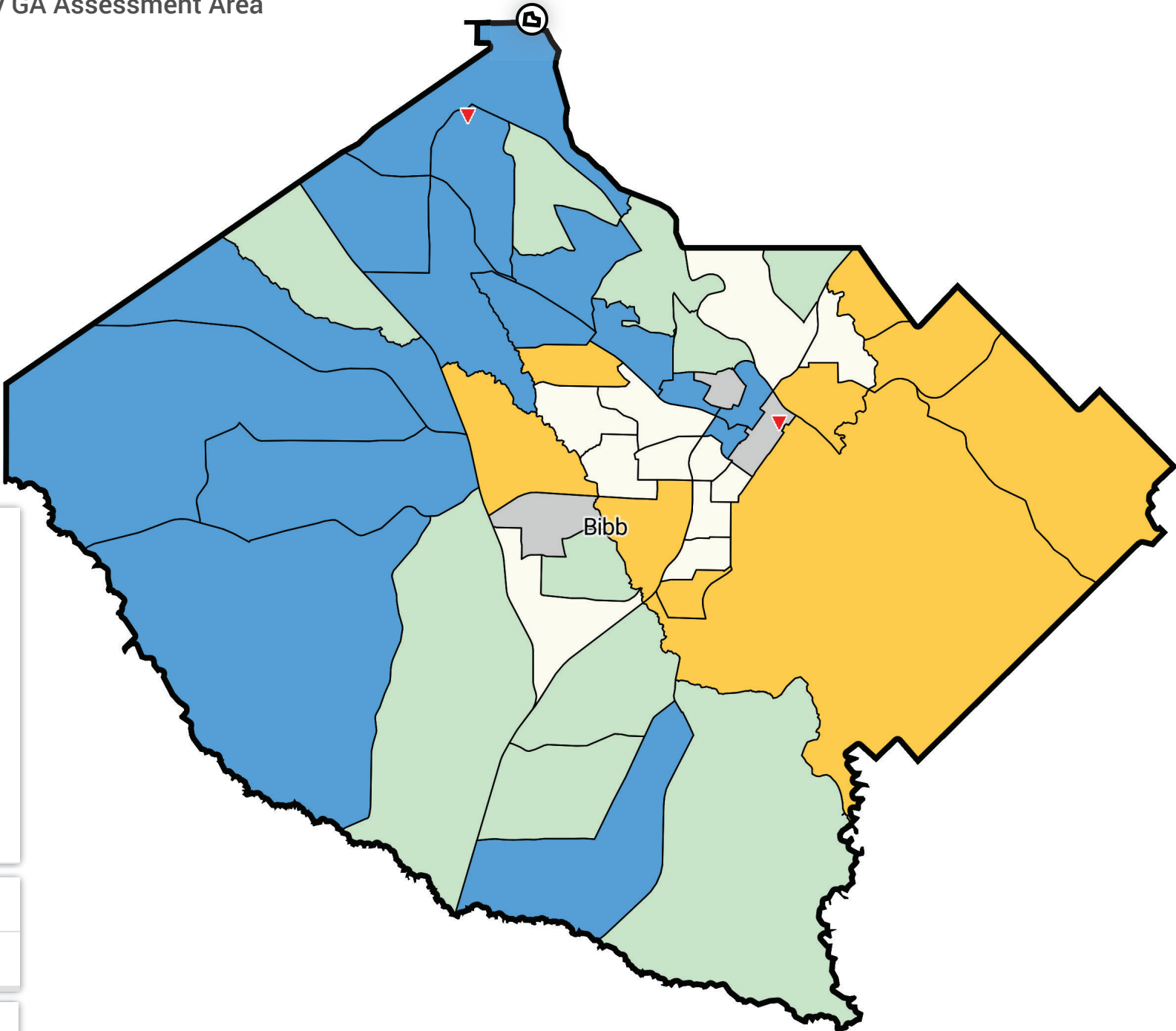

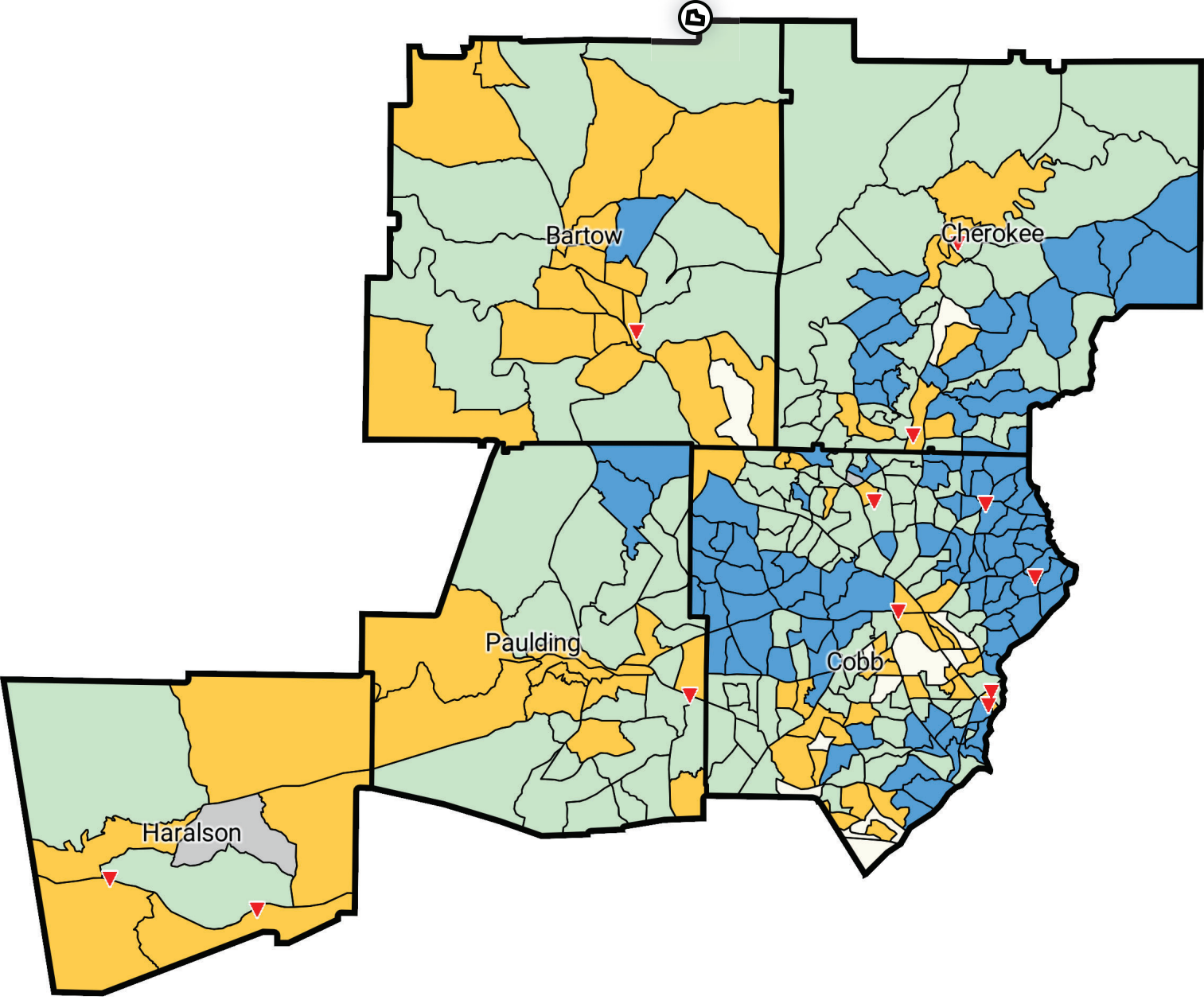

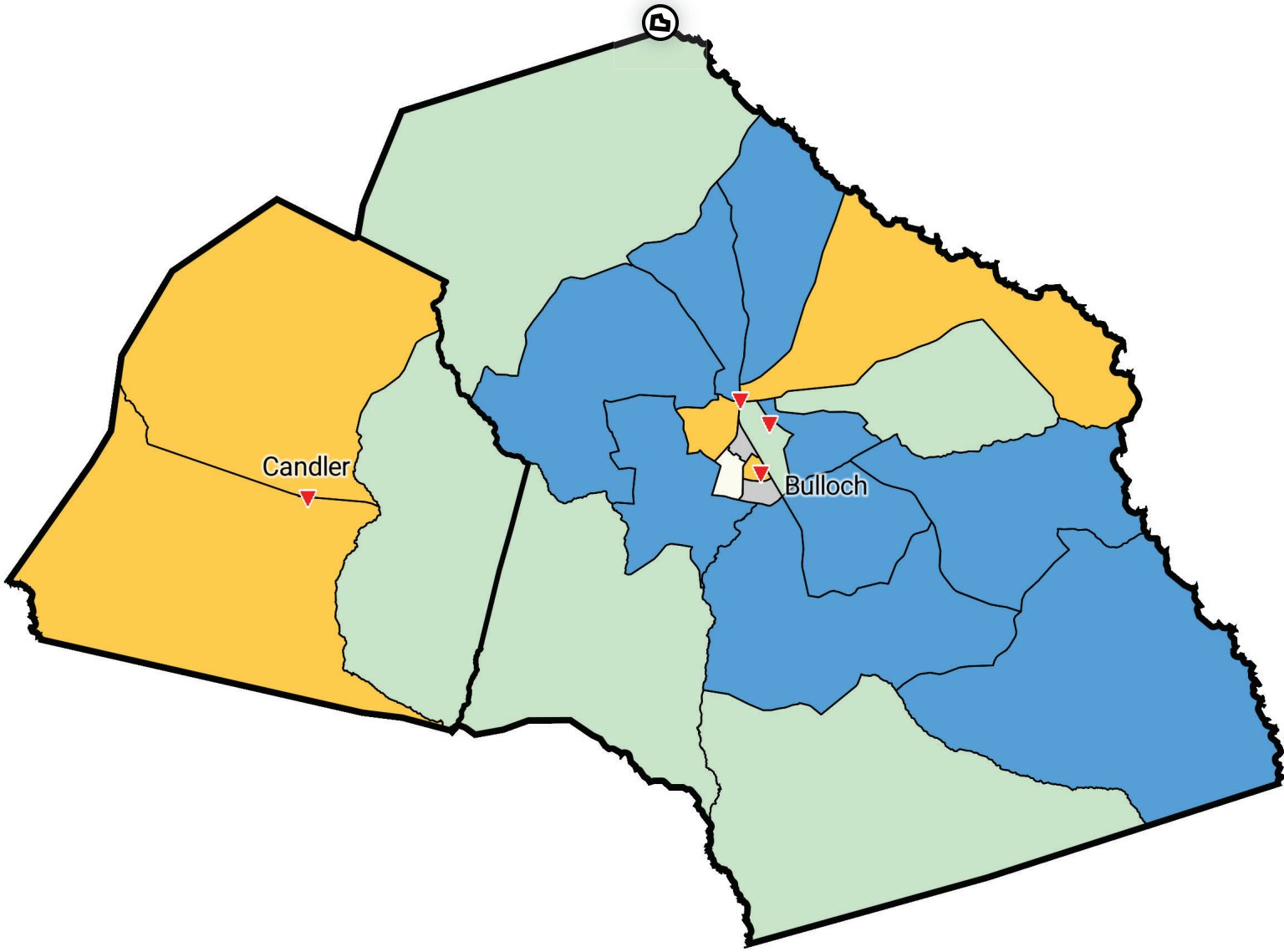

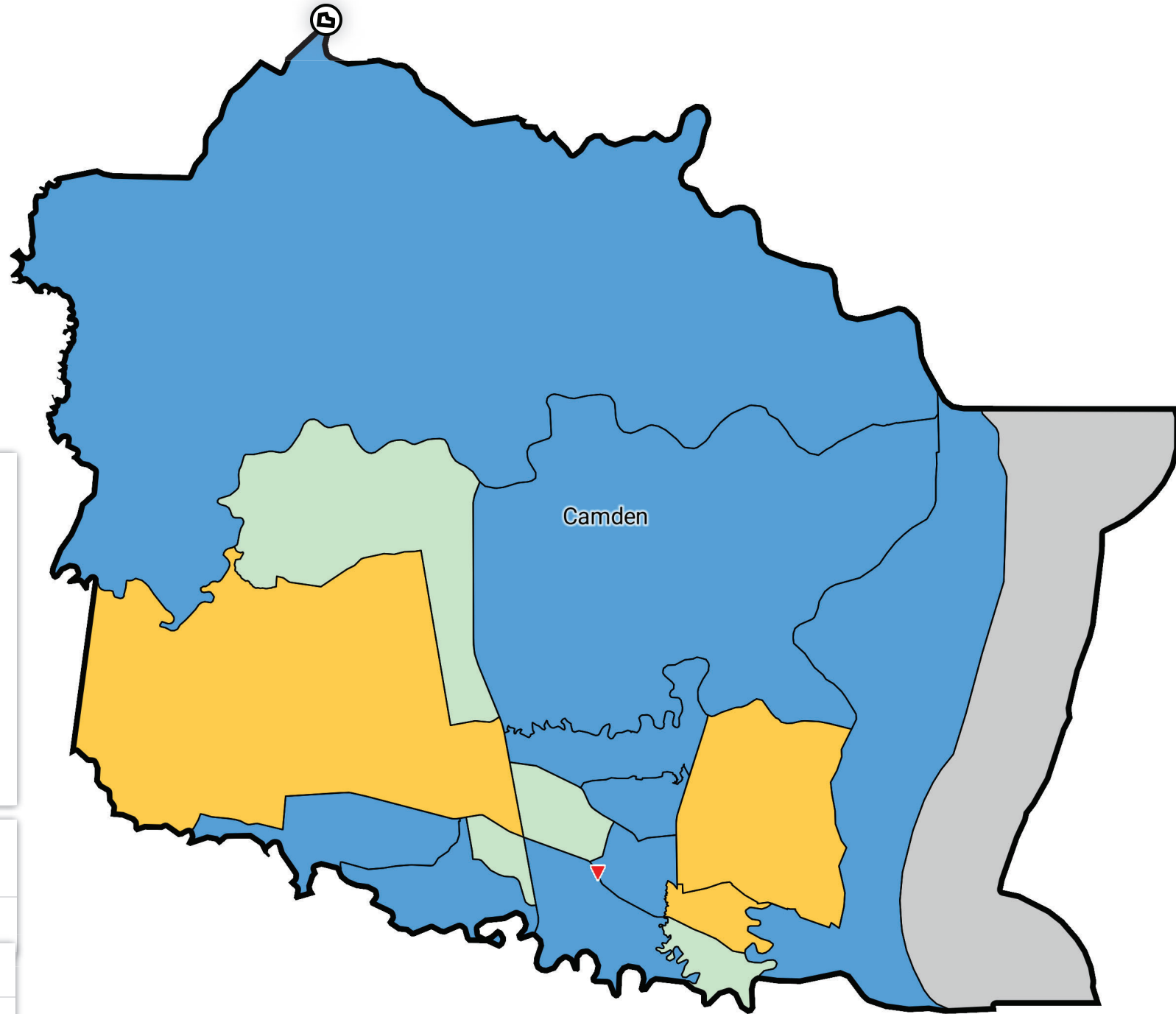

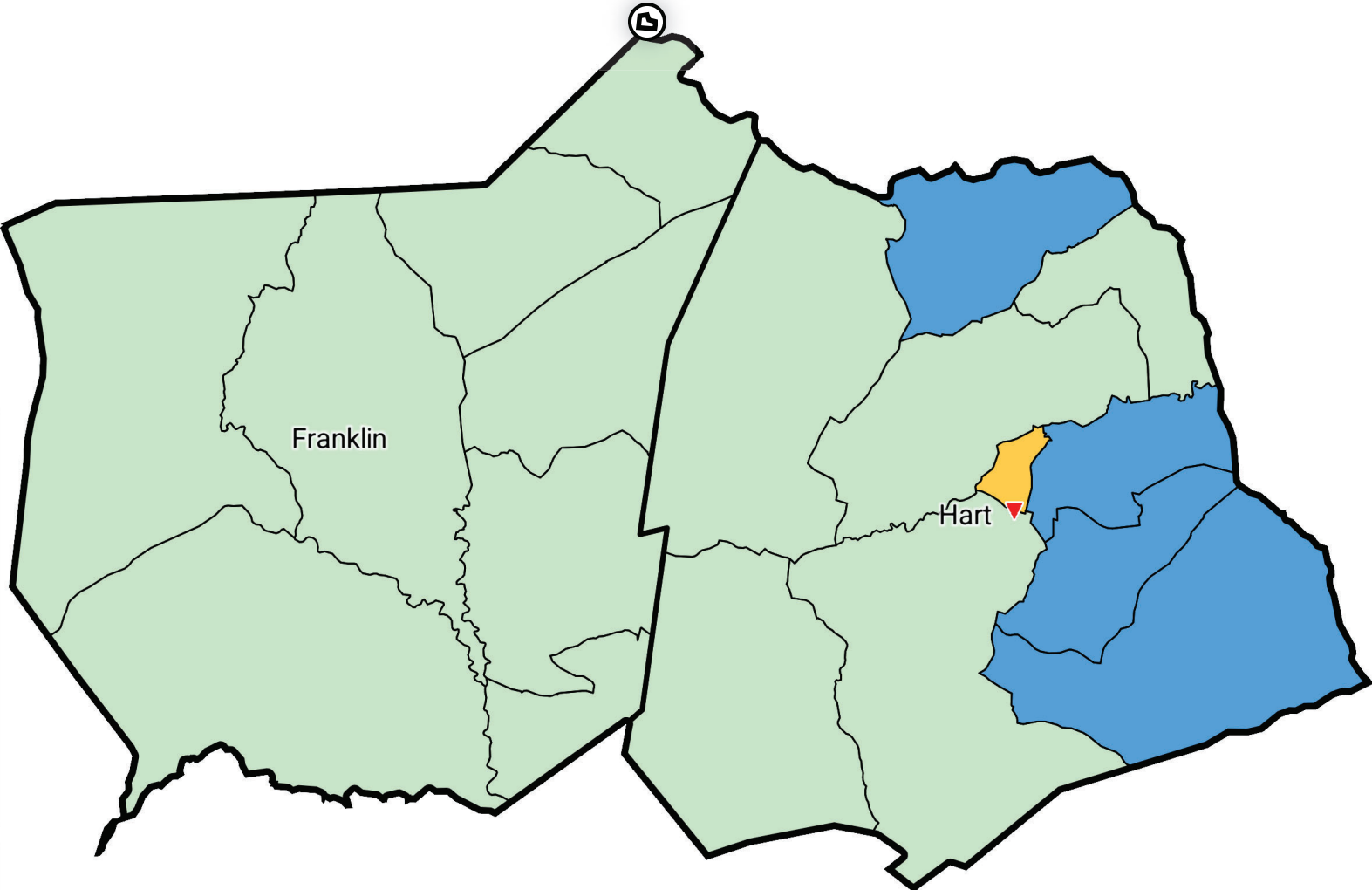

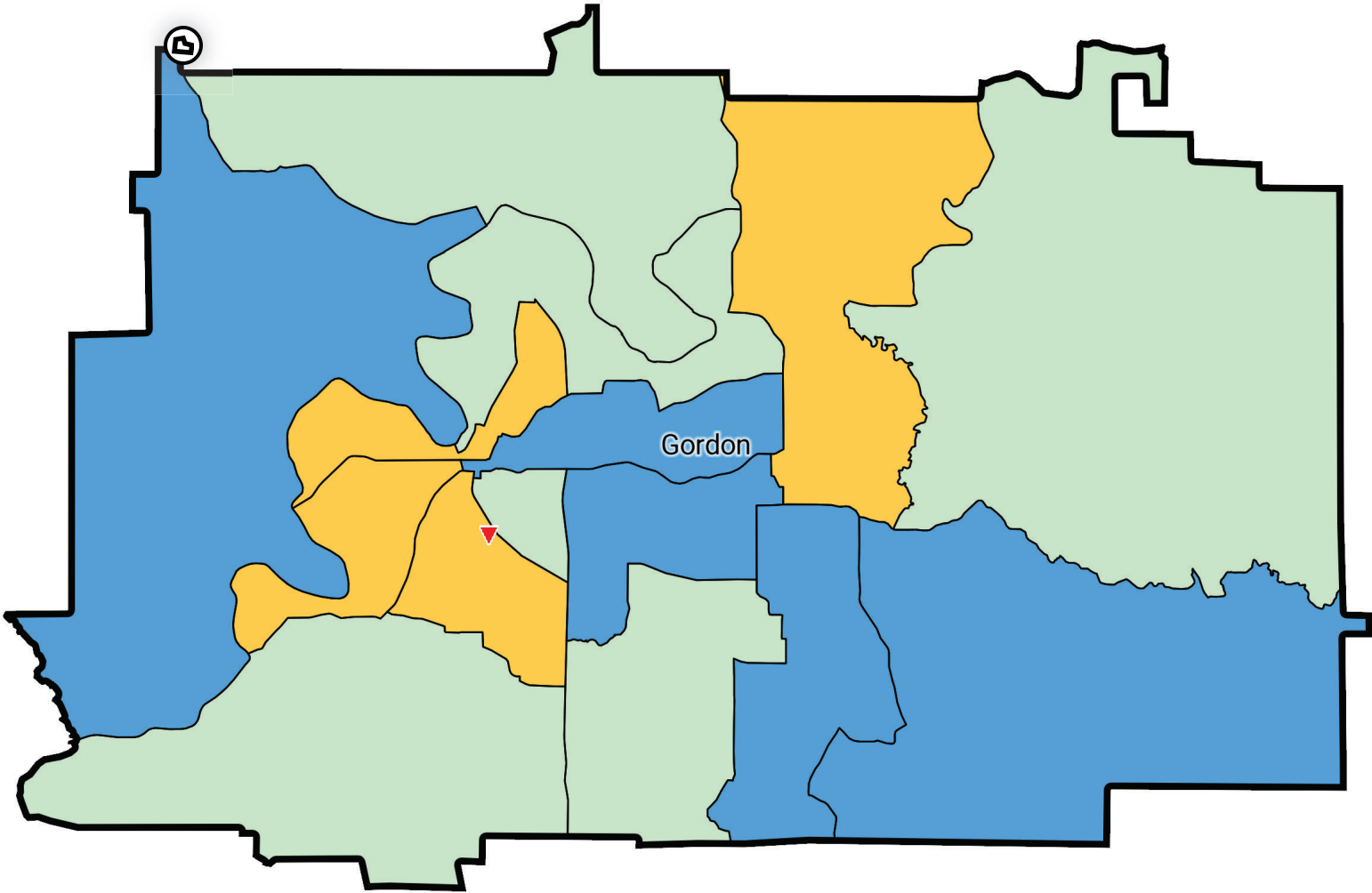

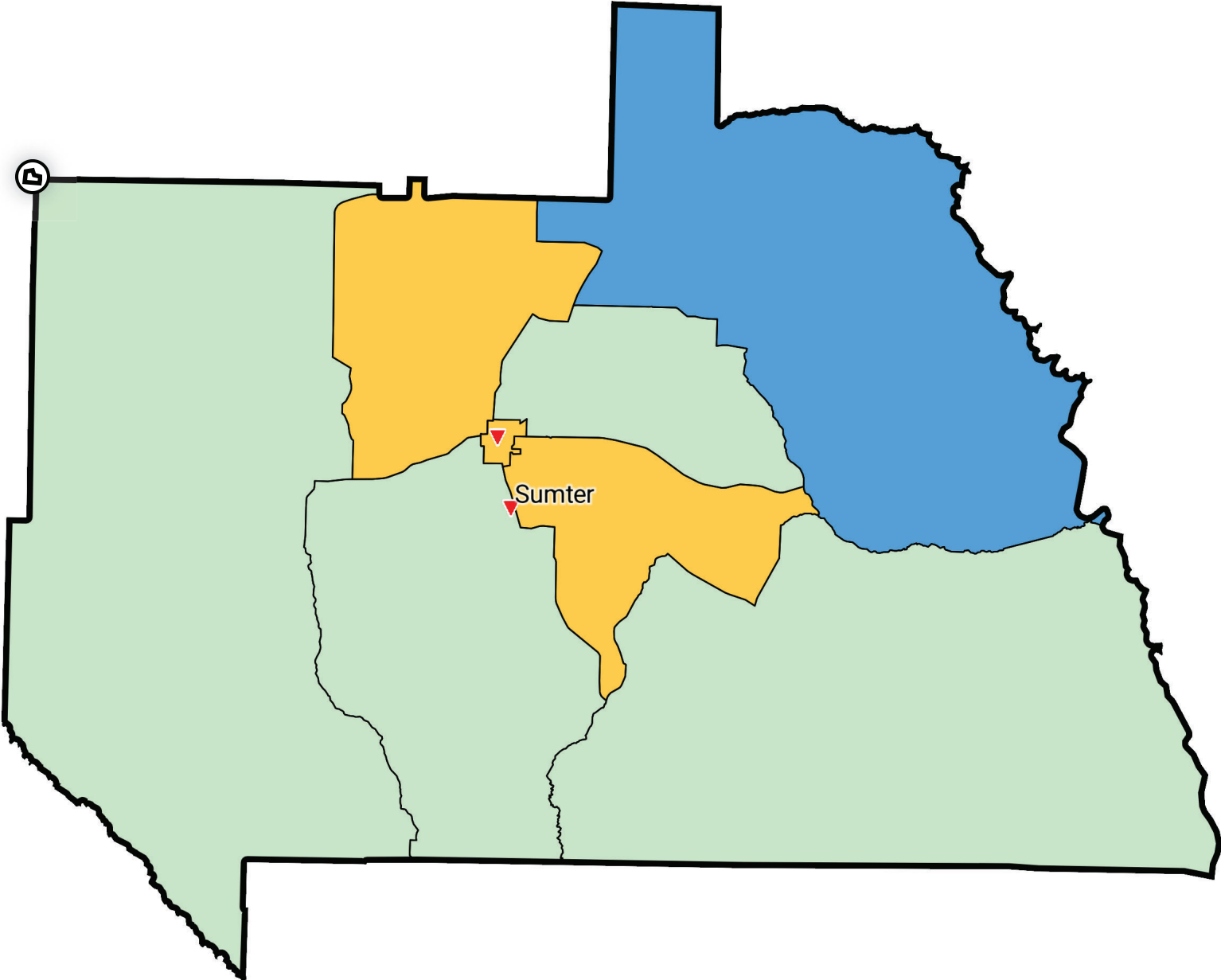

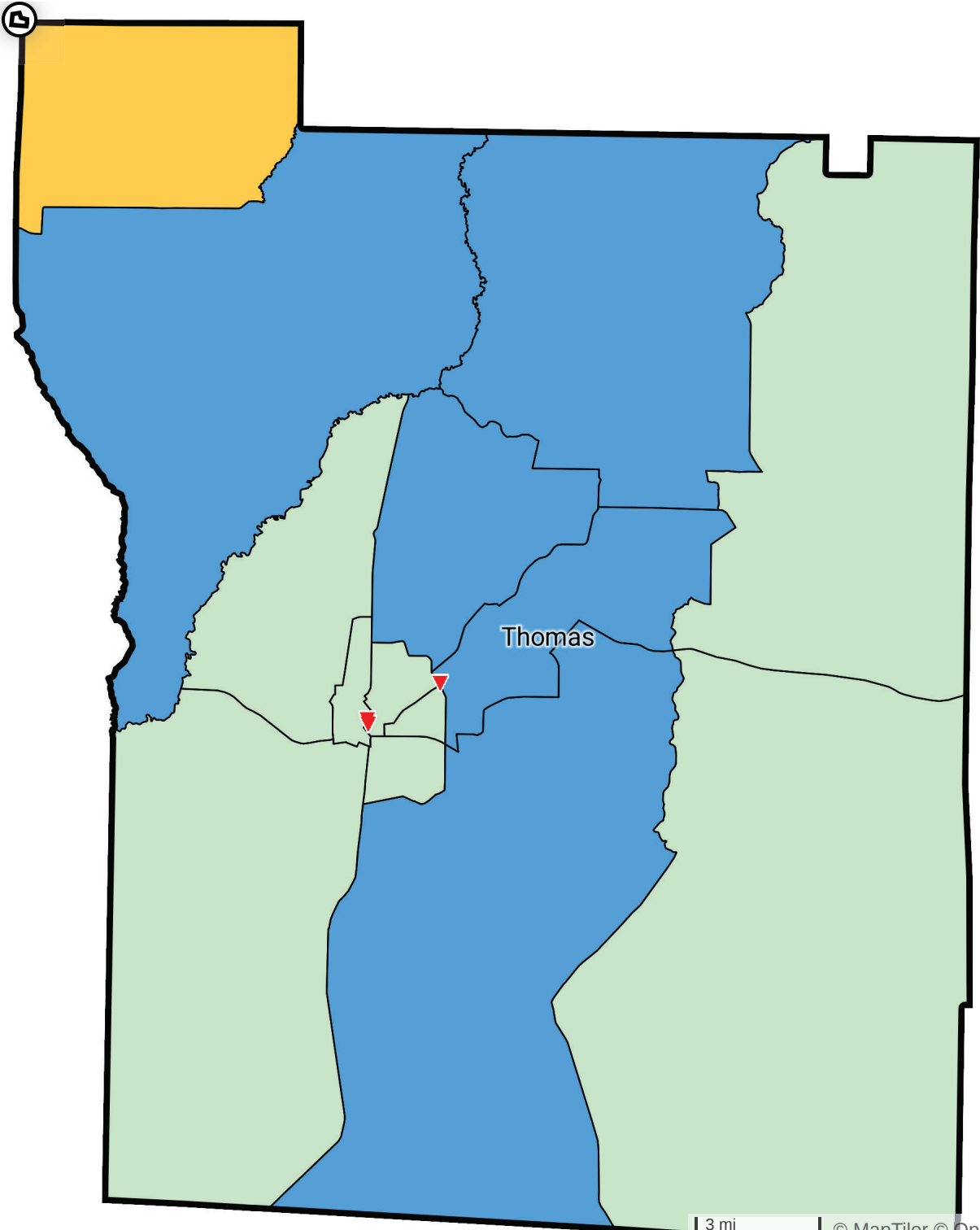

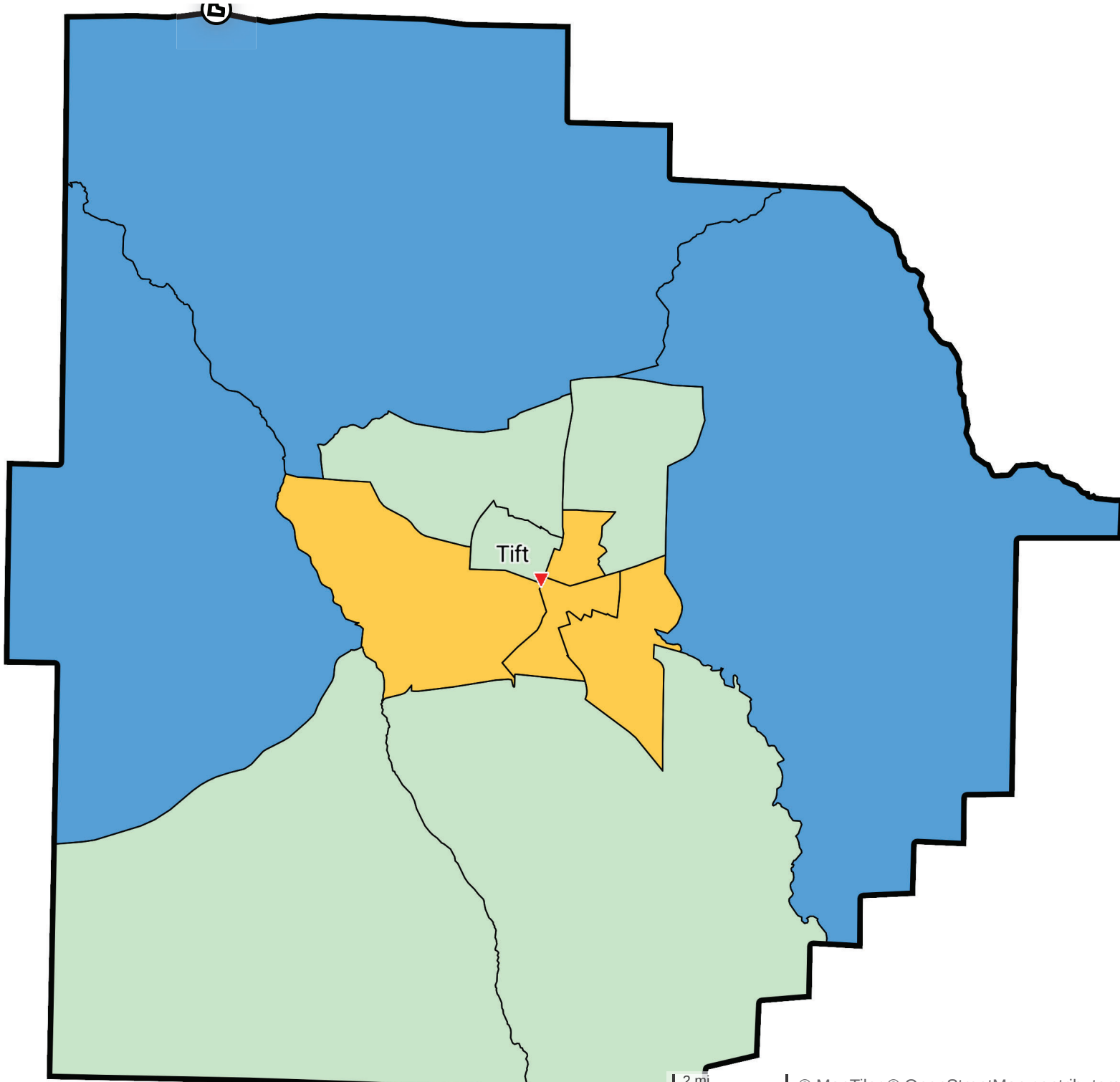

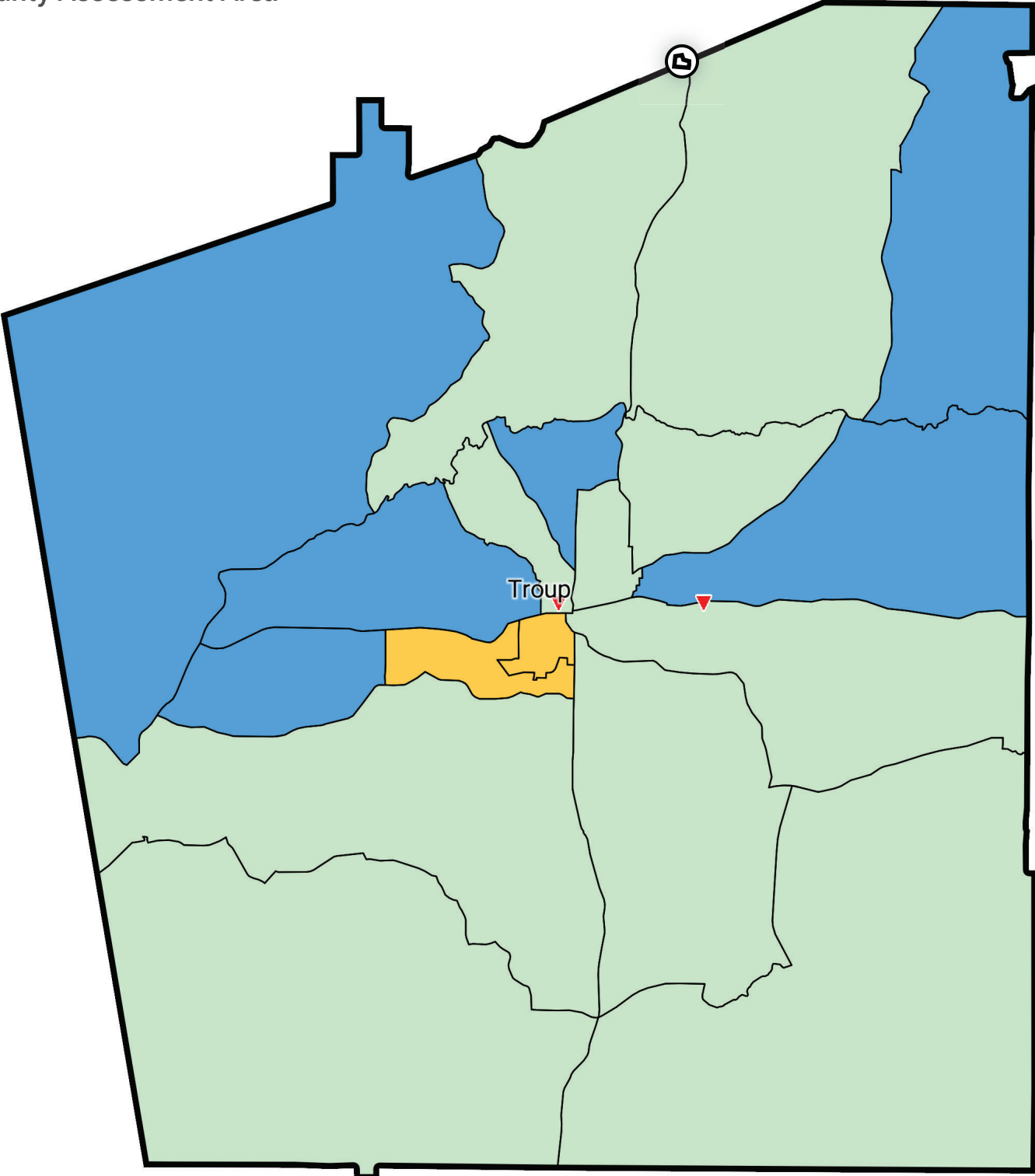

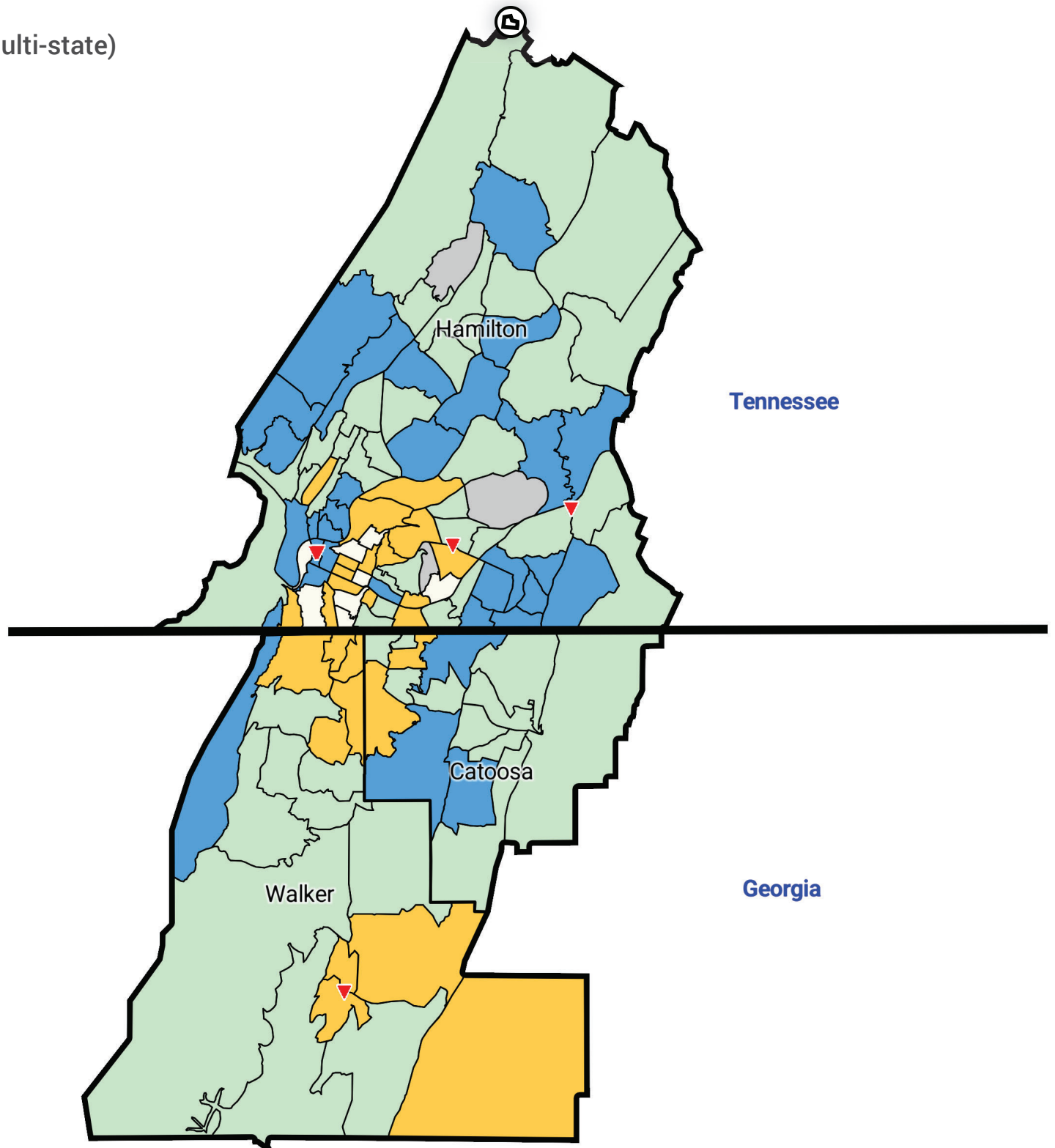

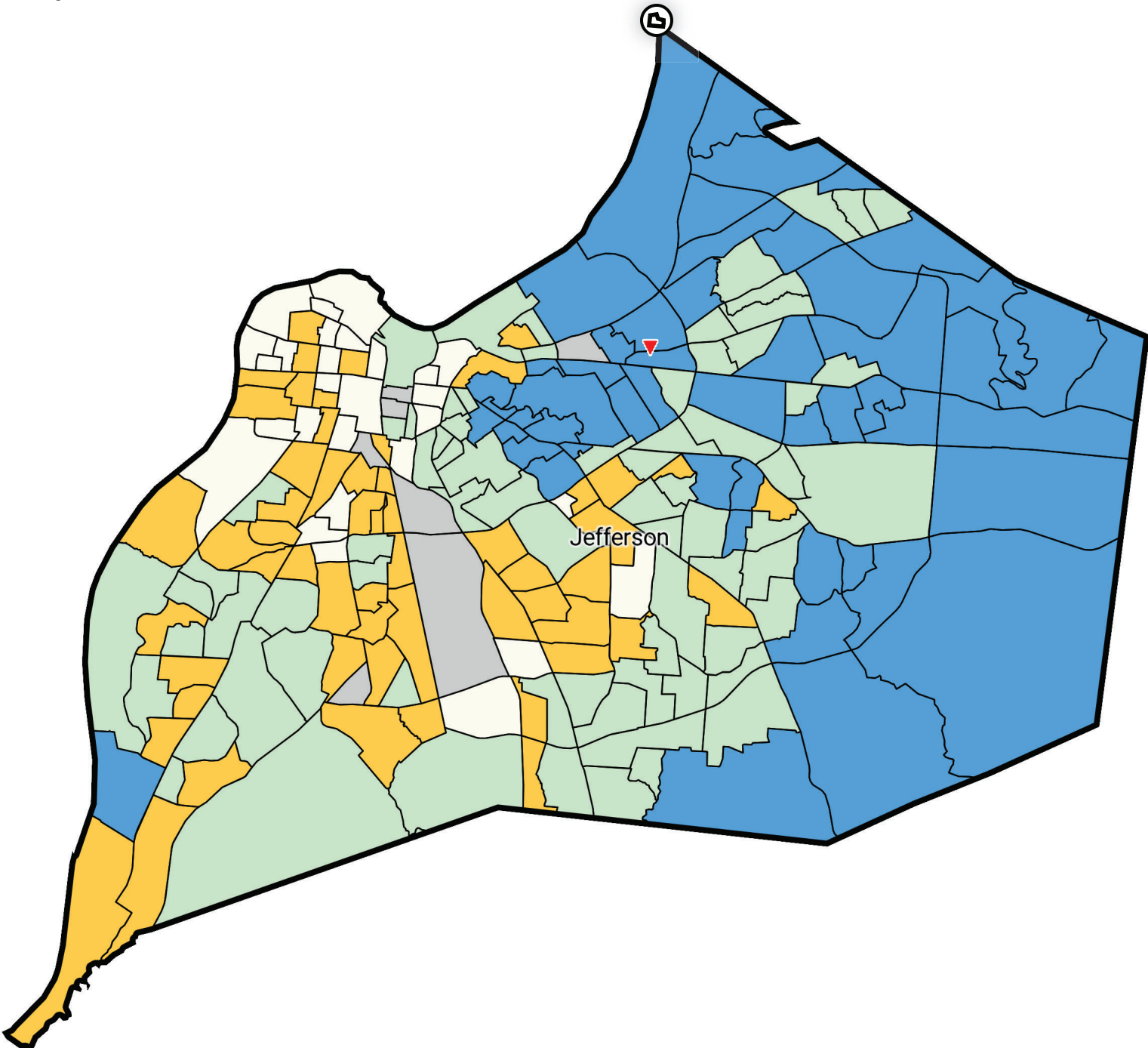

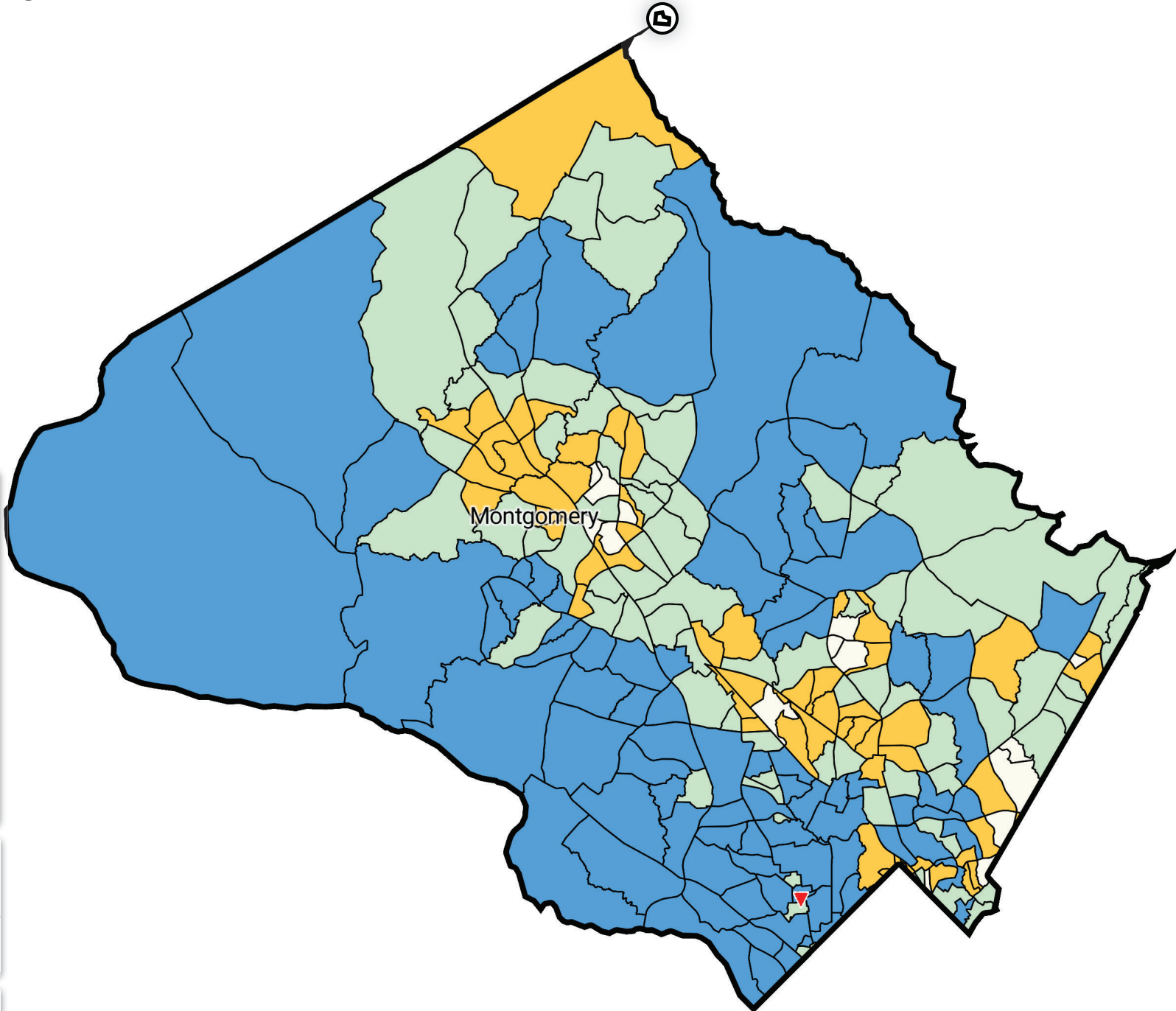
